Code of Conduct

If it is deemed by an employee, coach or volunteer that a team member has engaged in any inappropriate conduct, or breaks any of the rules of the gym, he/she can be suspended from practices or competitions or permanently terminated from Aero Elite Cheerleading. Grounds for these disciplinary actions are not limited to those listed below. They serve as guidelines only.

Aero Elite Cheerleading will NOT tolerate:

- Disrespect, insubordination, lack of cooperation toward a coach, captain or adviser.
- Unexcused absences from practices and/or competitions.
- Arguing or fighting with anyone on the team.
- Use of profanity.
- Being suspended from school.
- Any use of alcohol or drugs will not be tolerated! There is zero tolerance for this behavior.

We support our County School Board's "Pass to Play" policy. You must keep a 2.0 GPA to participate.

Rules of the Gym

- No gum, candy, soda, or food allowed in the gym.
- No jewelry while in uniform or at practices. No long fingernails.
- Hair must be worn away from the face. No large plastic or metal hair decorations.
- No one except team members and coaches are allowed anywhere in the practice area.
- Parents/Guardians, siblings, team members and potential team members only at each practice.
- No use of personal Cell Phones during practice.
- No spotting, tumbling, or stunting without a coach present.
- Respect coaches and teammates. There is no room for personal conflicts. Do not bring them to practice or competitions. This is not a hangout for friends. Make plans outside of practice.

Refund Policy

Annual Registration Fees will NOT, under any circumstances, be refunded.

In the event that a Participant is suspended from practice, there will be no refund, in part, nor in whole, of any fees paid for that current month. If the participant is suspended from practice the last 7 calendar days of a month, there will be no refund, in part nor in whole, of any fees paid for that current month nor the month following the suspension.

If a Participant is suspended from a Competition, there will be no refunds of any fees paid for that Competition. This includes, but is not limited to, fees paid for travel, registration, competition, food, lodging, or entertainment.

If a Participant voluntarily terminates or is involuntarily terminated from any Aero Elite Cheerleading program, there will be no refund, in part nor in whole, of the current month's fees. If a Participant voluntarily terminates or is involuntarily terminated the last 7 calendar days of a month, there will be no refund, in part nor in whole, of any fees paid for that current month nor the month following the termination.

If a Participant is voluntarily or involuntarily terminated within 45 days of a Competition, there will be no refund for that Competition. This includes, but is not limited to, fees paid for travel, registration, competition, food, lodging, or entertainment.

Aero Elite Cheerleading will refund only those fees returned from an agent, vendor or anyone acting on its behalf in part or in whole. Aero Elite Cheerleading shall be held harmless for an agent, vendor or anyone acting on its behalf not refunding fees paid to it for any reason, including, but not limited to their insolvency.
