## **Participant Agreement and Release Form**

In consideration of the services of Aero Elite Cheerleading, its owners, board members, officers, agents, coaches, employees, volunteers, and all other persons or entities acting on its behalf, for allowing my child to use these facilities, and participate in the program of Aero Elite Cheerleading, I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Aero Elite Cheerleading, from any and all claims, demands, and causes of action of any type or nature including, but not limited to, claims for pain, suffering, emotional distress, disability, medical expense, or damage to my son/daughter, to property, or to third parties, on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate.

I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Aero Elite Cheerleading from any and all claims, demands, or causes of action, present and future, whether the same be known, anticipated or unanticipated, of any and every nature, which are in any way connected with my son/daughter's participation in this activity or their use of Aero Elite Cheerleading's equipment or facilities in, on, or about the premises where the practices and competitions shall be conducted or any other location at which Aero Elite Cheerleading related activities occur, including any such claims which allege negligent acts or omissions of Aero Elite Cheerleading.
